Administrator's Report for February 6, 2024

General

First, we have a report from the Woodward Hill Water Project.

There are 10 resolutions on the agenda this evening:

The first is a resolution objecting to the annexation petition received by the Township requesting a total of 296.236+/- acres of land be annexed to the city of Huber Heights. This is part of the process as outlined in the ORC Section 709.023(D).

The second is to hire an attorney who specializes in annexation.

The next three are to appoint members and alternate members to the Township Zoning Boards.

Next is a resolution to give the Assistant to the Twp Admin, Mike Arnold, a salary increase for the purposes of cost of living adjustment and additional responsibilities

The next two are related to healthcare – one is to ensure that all employees are treated fairly and equitably when it comes to contributing to healthcare costs and in receipt of the benefits for the employees. The second is to set a policy to terminate healthcare when an employee or elected official resigns, retires, or is otherwise terminated.

Next is to make the \$2 hazard pay into a permanent salary increase.

The final resolution is to record the electronic payments and warrants.
