CONCORD TOWNSHIP BOARD OF TOWNSHIP TRUSTEES, MIAMI COUNTY, OHIO

The Concord Township Board of Township Trustees, Miami County, Ohio met in regular session on the 12th day of December ,2023, at the offices of the Concord Township Board of Township Trustees with the following members present: Donald D. Pence, Thomas N. Mercer, and Neil E. Rhoades.

Trustee Mercer moved the adoption of the following Resolution:

Resolution No 2023-09

A RESOLUTION TO PROHIBIT ADULT-USE CANNABIS OPERATORS FROM OPERATING WITHIN THE UNINCORPORATED AREA OF CONCORD TOWNSHIP, MIAMI COUNTY, OHIO

WHEREAS, on November 7, 2023, voters in Ohio approved State Issue 2 which enacts new Chapter 3780 of the Ohio Revised Code, effective thirty days from the date of the election (December 7, 2023); and

WHEREAS, Chapter 3780 authorizes and regulates recreational adult-use cannabis in the State of Ohio; and

WHEREAS, Ohio Revised Code section 3780.25 authorizes the Board of Township Trustees to prohibit or limit the number of adult-use cannabis operators (as defined in R.C. 3780.01) within the unincorporated area of Concord Township, Miami County, Ohio; and

WHEREAS, under Ohio Revised Code Chapter 3780 an "adult use cannabis operator" means a level I adult use cultivator, a level II adult use cultivator, an adult use processor, and an adult use dispensary; and

WHEREAS, the Board of Township Trustees finds it to be in the best interest of the unincorporated area of Concord Township, Miami County, Ohio, to prohibit adult-use cannabis operators licensed under Ohio Revised Code Chapter 3780 from operating within the unincorporated area of Concord Township, Miami County, Ohio.

NOW, THEREFORE BE IT RESOLVED by the Concord Township Board of Township Trustees, Concord Township, Miami County, Ohio that:

- 1. The term "adult use cannabis operator" and all other terms pertaining to adult-use cannabis shall have the same meaning as set forth in Ohio Revised Code Chapter 3780 as amended from time to time.
- 2. Adult-use cannabis operators are hereby prohibited from operating within the unincorporated area of Concord Township, Miami County, Ohio.

BE IT FURTHER RESOLVED that this Resolution shall become effective immediately upon its adoption and shall continue in effect indefinitely unless terminated by action of the Board of Township Trustees.

BE IT FURTHER RESOLVED that the Fiscal Officer is hereby directed to post a copy of this resolution in the usual places where the Board of Township Trustees posts public notices and to cause notice of this resolution to be published within a newspaper of general circulation within the unincorporated area of Concord Township, Miami County, Ohio.

BE IT FURTHER RESOLVED that all formal actions of the Board of Township Trustees concerning and relating to the passage of this Resolution were adopted in an open meeting of said Board, and all deliberations of said Board that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Ohio Revised Code Section 121.22.

RESOLUTION #24-02-030

A RESOLUTION TERMINATING HEALTHCARE INSURANCE EFFECTIVE NO LATER THAN THE FINAL DAY OF THE MONTH AT MIDNIGHT OF THE MONTH IN WHICH THE FINAL DAY OF EMPLOYMENT OCCURS

WHEREAS, the Board of Trustees of Bethel Township, Miami County, believes all employees and elected officials should be treated fairly and equitably; **AND**

WHEREAS, the Board of Trustees of Bethel Township, Miami County, believes the Board should be good stewards of taxpayer monies and not set a precedent by unfairly giving employees additional health, dental, or vision insurance beyond their last day of employment at taxpayer expense; **AND**

WHEREAS, currently there is no evidence that employees contribute to their health, dental, or vision insurance plans in advance of when the premiums are due and paid; **AND**

WHEREAS, the Township may allow employees to purchase insurance(s) funded by the employee in its entirety and the Trustees believe that employees should have the option to continue said insurance(s), at the employee's discretion and expense, through the end of the employee's final month of employment. **THEREFORE**

BE IT RESOLVED, by the Board of Trustees of Bethel Township, Miami County, that the contribution amount shall continue to be collected from employees and elected officials in arrears and authorizes the Fiscal Officer to collect any outstanding balance due to the Township or refund any amount due the employee from/to the employee's final paycheck.

BE IT FURTHER RESOLVED, for insurance(s) funded wholly or in part by the Township, that the Board of Trustees authorizes the Fiscal Officer or the Township Administrator, in all cases, to terminate the relevant health, life, dental, or vision insurance of employees who have left the employment of the Township or are no longer an elected official, effective the employee's or elected official's final day at the Township at midnight.

BE IT FURTHER RESOLVED, for insurance(s) funded wholly by the employee or elected official, that the Board of Trustees authorizes the Fiscal Officer or the Township Administrator, in all cases, to terminate the relevant health, life, dental, or vision insurance of employees who have left the employment of the Township or are no longer an elected official, effective no later than the final day of the month at midnight of the month in which the employee's or elected official's final day at the Township occurs.
