Water Line Grant Funding

In October, Bethel Township was the recipient of a \$400,000 Ohio Public Works Commission (OPWC) grant for the purpose of constructing water lines in and around Phoneton. An additional \$200,000 loan at 0% interest was also part of the OPWC funding. Bethel Township is currently working with Miami County Sanitary Engineering to select an engineering firm for the design of the project. The estimated cost of the project is approximately \$1,500,000. 3.8 mill Levy funds will be used to offset a portion of the assessment costs. The water line will eventually connect to the water lines in Wiley Industrial Park. Water in the Wiley Industrial Park is currently supplied by Huber Heights. The estimated flow through the lines is over 46,000 gallons of water per day! The project should go out to bid for the construction by the fall of 2014 and construction will begin in the spring of 2015. As the project progresses, we will keep you updated on the design milestones, construction dates and costs.

3.8 mill Levy Passes

In November, Bethel Township voters renewed the 3.8 mill Bethel Township General Fund Levy. The official results show that the levy passed, 59% to 41%. The monies generated by this levy will continue to fund infrastructure projects in Bethel Township.

Road Maintenance

December brought quite a bit of snow and ice and then a deluge of rain. The weather made driving a challenge for all of us. As winter continues, we'd like to remind everyone again about the following snow removal tips. The Bethel Township Road Department makes every effort to keep roadways as safe as possible during inclement weather.

Snow removal tips

To help snow removal crews complete each snow event in the most efficient manner, the Road Department asks residents to do the following:

- Remove any objects, *including vehicles*, near or on roadways that could potentially be struck during snow and ice removal.
- Don't pass a snow plow unless absolutely necessary.
- Allow plenty of stopping distance and keep a safe distance behind the plow trucks. This also reduces the chances of loose material hitting your vehicle.
- Never assume that the snow plow operator can see you. Every plow truck has blind spots that reduce side and rear visibility.
- Delay non-essential travel until after the roads have been cleared.
- Keep headlights on low beam.
- When clearing your driveway, do not push the snow out into the street. This can create a danger to motorists.
- To avoid clearing your driveway entrance repeatedly, wait until the plow truck has completed clearing the roadway. Pile snow to the left side of drive as you face your house, specifically when clearing near the road. This will prevent the plow from dragging the pile across your driveway apron.

Plowing responsibilities

Not all roadways within Bethel Township are maintained by Bethel Township. Certain roadways are maintained by other government agencies or private concerns. The Bethel Township Road Department maintains approximately 26 miles of the 75 miles of roadway in the Township.

- The Ohio Department of Transportation (937) 339-1921 maintains all state routes.
- The Miami County Engineer's Office (937) 440-5656 maintains County roads. In our township, county roads are Bellefontaine, Elizabeth—Bethel, Palmer, Studebaker, Scarff (north of New Carlisle Road), Dayton-Brandt, Ross, Sullivan and Rudy.
