On the Ballot November 3, 2015

On the ballot in November, will be several items for township voters to consider.

Bethel School Board: There are two seats up for election in November. Four people are running for these positions: Greg Brueckman, Jacob King, Lory Sebastian and Todd Wright. Three of the candidates are write in candiates. School board members serve a four year term and there are five school board members.

Township Trustee: There are two township positions that are up for election. Deborah Watson is running for fiscal officer and Gary Biggs is running for trustee. They are running unopposed. All positions are four year terms, the township board is made up of three trustees and a fiscal officer.

2.1 mil Road & Bridge Levy: This is a new levy. The funds from this township levy can only be used for road maintenance—repaving, pothole repair, plowing, roadside mowing & tree trimming, berming, crack sealing, etc. and repair and purchase of road equipment. It will cost a homeowner \$73.50 per year for a \$100,000 home, or \$0.20 per day. This levy is a five year levy. For additional information, see the article on page 3.

2.5 mil Renewal Tax Levy: This is a Miami County Board of Developmental Disabilities levy. This five-year levy generates \$5,325,662.40 per year, which is 39.08% of the Riverside's Developmental Disabilities operating budget. Services provided with these funds for nearly 900 people in Miami County include case management, early intervention services, physical and occupational therapies, recreational activities, community housing coordination, community employment training and placement, adult day services, and transportation. This levy will cost a homeowner about \$87.50 per year for a \$100,000 home or \$0.24 per day. This is voted on by all Miami County voters.

0.45 mil Renewal Tax Levy: This is for Miami County bridge construction and repairs. All Miami County voters will vote on this levy, which was originally approved by voters in 1951. The levy generates about \$900,000 a year and will cost a homeowner about \$15.75 per year for a \$100,000 home or \$0.04 per day. This is a five year levy.


Road Repaving

Scarff Road, between 571 and New Carlisle was repaved in September at a cost of \$119,000 for a little over 1 mile of road. The last time this section of Scarff was paved was in 1993. As many drivers can attest, the road was past due for repaving. Due to an extremely tight budget, this is the only road that the township will repave this year. Pothole repair and crack sealing will continue to be done throughout the fall. The county repaved Scarff Road from New Carlisle Road to Dayton Brandt and a short section of Studebaker between 201 and Dayton-Brandt. All roads will be striped by the county in October.

2.1 mil Road and Bridge Levy on the Ballot

This November, a 2.1 mil Road & Bridge Levy will be on the ballot. This is a *new* levy and a *township only* levy. Bethel Township currently does not have any road levies. The funds from this levy can only be used for road repairs and equipment: pavement repair, resurfacing, roadside mowing, culvert maintenance and replacement, overhanging tree trimming, snow/ice removal, and berm maintenance, road crew salaries, insurance, fuel, salt, asphalt, etc. The township employs one full time road worker and several part time seasonal road workers. The 2.1 mil Road and Bridge Levy will cost a homeowner \$73.50 per year for a \$100,000 home, or \$0.20 per day. It will generate \$280,266 annually. This will allow us to repave roads on a 15 year cycle, rather than every 100 years and maintain and replace our equipment in a conservative manner without having to borrow money.

Despite all our frugal spending measures, costs (fuel, salt, insurance, apshalt, repaving) continue to increase. The four funds (Road and Bridge Fund, Gasoline Tax, Motor Vehicle Tax and the Permissive Motor Vehicle Tax) that generate the current monies have been fairly steady and there have been no raises in salary for the road department workers since 2008. Due to shifts in the state government spending, the township has lost over \$192,000 in annual revenue that was used for fuel, vehicle maintenance, road department salaries, building repair, insurance and other things. Our equipment is aging—and while we do many repairs and maintenance in house, all vehicles have a life expectancy and at some point will need to be replaced. Frugal spending combined with conservative estimating suggest that the township, with current funding, could repave one mile of road approximately every four years. This makes the "paving cycle" for all 25 miles possible only every 100 years. Clearly, this is not an acceptable option.

The trustees are very conscious of the need to keep taxes as low as possible. Every effort is made to reduce costs and to keep expenses at a minimum. With the substantial loss of annual tax revenue to the general fund (both state and local) over the last few years, combined with the increase in asphalt, salt, insurance, salaries, vehicle and fuel costs, we feel a 2.1 mil Road & Bridge Levy is the best solution to proactively maintain the integrity and safety of our roads and our community.
