A RESOLUTION AUTHORIZING RAISES TO BETHEL TOWNSHIP CURRENT FULL TIME AND PART TIME EMPLOYEES

WHEREAS, PERIODICALLY BETHEL TOWNSHIP NEEDS TO ADJUST THE PAY RATE OF EMPLOYEES TO MAINTAIN A COMPETITIVE WAGE, THEREFORE;

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY THE PAY SCALES OF IT'S FULL TIME EMPLOYEES AND PART TIME EMPLOYEES PER THE FOLLOWING SCHEDULE AND DIRECT THE BETHEL TOWNSHIP FISCAL OFFICER TO MAKE THE NECESSARY HOURLY/SALARY ADJUSTMENTS AND TO MAKE THESE ADJUSTMENTS STARTING JANUARY 1, 2017.

- 1: THE ANNUAL SALARY FOR THE FULL TIME ROAD WORKER BE ADJUSTED BY ADDING 4%.
- 2: THE ANNUAL SALARY FOR FULL TIME ASSISTANT TO THE ADMINISTRATOR BE ADJUSTED BY ADDING 4%.
- 3: THE ANNUAL SALARY FOR THE TOWNSHIP ADMINISTRATOR BE ADJUSTED BY ADDING 5%.
- 4: THE HOURLY RATE FOR PART TIME RECEPTIONIST BY INCREASED BY \$.25/HR.

5: AN ANNUAL ONE TIME BONUS BE PAID TO THE AFOREMENTIONED EMPLOYEES PRIOR TO JANUARY 2018 IN THE AMOUNTS PRESCRIBED BY THE BETHEL TOWNSHIP TRUSTEES.
