WHEREAS, the Bethel Township Board of Trustees, Miami County, Ohio (the "Board") desires to regulate the placement of Junk Motor Vehicles located within the unincorporated territory of Bethel Township, Miami County, Ohio pursuant to the authority granted to the Board under Ohio Revised Code section 505.173.

NOW, THEREFORE BE IT RESOLVED, that pursuant to the authority granted to the Board under Ohio Revised Code section 505.173:

Section 1. No person shall openly, store, park, or have any Junk Motor Vehicle on private or public property within the unincorporated territory of Bethel Township, Miami County, Ohio, unless such Junk Motor Vehicle is stored, parked or contained within, or concealed by, buildings, fences, vegetation, terrain, or other suitable screening from public view.

If a Junk Motor Vehicle is not stored, parked or contained within, or concealed by, buildings, fences, vegetation, terrain, or other suitable screening from public view, then the Board shall send written Notice of such fact to the person or persons who have the right of possession of the real property upon which such Junk Motor Vehicle is stored or parked. Such Notice shall also indicate that the Junk Motor Vehicle must be stored, parked or contained within, or concealed by, buildings, fences, vegetation, terrain, or other suitable screening from public view,

If the person or persons having the right of possession to the real property upon which the Junk Motor Vehicle is stored, parked, or placed does not contain or conceal the Junk Motor Vehicle from public view pursuant to this resolution within 14 days after receipt of written Notice to do so, such person or persons shall be a guilty of a minor misdemeanor. Each day that such violation continues shall constitute a separate offense.

Section 2. Nothing contained in this resolution is intended to limit the ability of the Board to institute and/or undertake other remedies provided by law including without limitation an action for injunction, mandamus, or abatement, or any other appropriate action or proceeding to prohibit the storage of junk motor vehicles in violation of this resolution or pertinent Ohio Revised Code sections.

Section 3. Nothing contained in this resolution is intended to limit the ability of the Board to pass other resolutions for the regulation of Junk Motor Vehicles pursuant to Ohio Revised Code section 505.173 or any other Ohio Revised Code section.

Section 4. This resolution does not apply to the operations of a scrap metal processing facility licensed under R.C. Sections 4737.05 to 4737.12; a motor vehicle salvage dealer, salvage motor vehicle auction, or salvage motor vehicle pool licensed under R.C. Chapter 4737; or a business providing towing or recovery services pursuant to R.C. sections 4513.63.

Section 5. As used in this resolution, the term "Junk Motor Vehicle" means a motor vehicle, including a "collector's vehicle" that meets all of the following criteria:

A. Three model years old, or older; and

- B. Apparently inoperable; and
- C. Extensively damaged, including, but not limited to, any of the following: missing wheels, tires, engine, or transmission.

For purposes of this Resolution, and regardless of whether it is licensed or unlicensed, a "collector's vehicle", as that term is defined by the Ohio Revised Code, is a "Junk Motor Vehicle" if it meets all the criteria set forth in this Section 5.

In addition, a copy of such notice shall be posted on the principal structure on the Property and a photograph taken of such posted notice with a camera capable of recording the date of the photograph on it. If the owner's address is unknown and cannot be reasonably obtained, the notice shall be published once in a newspaper of general circulation in the Township.
- E. The contents of the notice shall:
- 1. Order the owner to abate, control, or remove the vegetation, garbage, refuse, or other debris, to-wit: garage sale items, tall grass and weeds, junk vehicles, lawn mowers, etc., the owner's maintenance of which has been determined by the Board to be a nuisance;
- 2. State that if that vegetation, garbage, refuse, or other debris previously described is not abated, controlled, or removed, or if provision for its abatement, control, or removal is not made, within seven (7) days, the Board shall provide for the abatement, control, or removal. Any expenses incurred by the Board in performing that task shall be entered upon the tax duplicate and become a lien upon the land from the date of entry.
- F. A copy of this Resolution shall accompany the mailed notices.
- G. The Bethel Township Fiscal Officer ("Fiscal Officer") or her designee shall send, post and/or publish the above notices on behalf of the Board.
- H. If, within seven (7) days after notice is given pursuant to this Resolution, the owner of the Property fails to abate, control, or remove the vegetation, garbage, refuse, or other debris as previously described, or no agreement for its abatement, control, or removal is entered into under R.C. § 505.87(D), the Board shall provide for the abatement, control, or removal of such nuisance and may employ the necessary labor, materials, and equipment to perform the task.
- I. All expenses incurred to abate, control, or remove the vegetation, garbage, refuse, or other debris previously described, when approved by the Board, shall be paid out of the Township general fund from moneys not otherwise appropriated.
- J. Pursuant to R.C. § 505.87, the Board shall collect the total cost of abating, controlling, or removing the vegetation, garbage, refuse, or other debris from the Property. To do so, the Board shall make a written report to the Miami County Auditor of the Board's action. The Board shall include in the report a proper description of the Property and a statement of all expenses incurred and the date of their incurrence in providing for the abatement, control, or removal of any vegetation, garbage, refuse, or other debris from the Property, including the Board's charges for its services, the costs incurred in providing notice, any fees or interest paid to borrow moneys, and the amount paid for labor, materials, and equipment.
