STAFF REPORTS

ADMINISTRATOR

There are four Resolutions on the agenda this evening.

1: The first is for the last round of Cares funding income for 2020. This income changed the overall balance of the fund 2271 which is the Cares funding; therefore, a supplemental appropriation must be done.

2: The second and third are year-end fiscal Resolutions. One for the final year end resources and the other to carry over temporary appropriations for 2021.

3: The last Resolution is for the purchase of a 2020 Ford F-150. This will be used as a generalpurpose vehicle for the Township. Currently we only have dump trucks and fire vehicles in the Township Fleet. This vehicle will keep fire vehicles separate and allow for things such as inspections, supply trips, bank deposits, etc. This will utilizing CARES Act funding.

4: All flooring, painting, network, gear washer projects are complete. We currently are awaiting the installation of the gear dryer and UV Lights. This will complete all CARES Act projects.


