STAFF REPORTS

ADMINISTRATORS REPORT

There are two resolutions and one proclamation on your agenda tonight.

The proclamation is to declare the Month of May to be Mental Health Awareness month.

The two resolutions are for the renewal of the Township's Health and Life insurance. The health insurance is recommended to renew with Anthem. It will be a similar policy with a higher deductible, for a single plan it will increase \$250 and for the family plan it will increase by \$500. The unusual thing is that the Township's premiums will decrease by 2.29%. The life insurance is thru United Health Care and the rates are the same for this year.

- 1: The Fire Department will be conducting a major training at the schools old rental property on Saturday, May 1st. We will be utilizing burn barrels and will be generating a lot of smoke in the area.
- 2: The Fire Department just completed EMS trainings on Stroke, Sepsis, and Human Trafficking. With the human trafficking we were instructed on how to recognize victims in the EMS environment.
- 3: The roadside mower is scheduled to be fixed this Thursday. If the fix is successful, we can begin/resume roadside mowing.

4: We are currently working on solutions to the drainage issues on Bethelville and Palmer. We met with the County Commissioners and County Engineer to move forward with the possible solutions. The County Engineer asked for two months to come up with the initial recommendations.



WHEREAS, THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY ARE PERMITTED TO PROVIDE SUCH BENEFITS TO THEIR FULL TIME EMPLOYEES AND ELECTED OFFICIALS, THROUGH SECTION 505.60 OF THE OHIO REVISED CODE, AND
WHEREAS, THE FISCAL OFFICER WITH THE ASSISTANCE OF MCGOHAN BRABENDER INSURANCE HAS IDENTIFIED ANTHEM BLUE CROSS BLUE SHIELD. AS THE BEST OPTION FOR PROVIDING COVERAGE TO THE TOWNSHIP, THEREFORE,
