

ADMINISTRATORS REPORT

General

There are two Resolutions on the agenda this evening.

The first is accept the Final Year End Amended Certificate of Estimated Resources from the Miami County Budget Commission and presented by the Fiscal Officer. This Certificate shows the final resources Bethel Township Received for the fiscal year 2021.

Next is a Resolution to hire Ricky Davis to the Bethel Township Fire Department. Ricky is a certified EMT-Basic and Firefighter.

Other:

There has been a developer that has contacted the Township wanting to annex 115 acres at the intersection of Scarff and New Carlisle to the City of New Carlisle. This is an area with no utility service provided by Bethel Township or Miami County. We have just found out about this and will have more information to follow.

The snow event last week brought several inches of snow to the Township. Road crews worked most of the day and night on Thursday and started again at 4am on Friday. The crews did a great job with only 2 complaints, a driveway where is the snow was pushed in front of at a dead end and a mailbox that could not be reached due to high snow.

TRUSTEE REPORTS

Trustee vanHaaren: She stated that she had two complaints about a raw sewage smell West Charleston. I talked to the Health Department about it and she took the information down. Later in the week I spoke to a guy on Scarff Road and he said there was dumping of bio solids and wanted to know if they had a permit. I checked and they do have a permit and are following proper procedures.

Trustee Reese: Bethel School Board Joint Meeting is set for March 1, 2022 at the school, at their workshop session.

Stated that she attended the OTA conference and I attended the Legislation Reception and spoke with Ohio Senator John Huffman. She asked him to change the laws to help Townships with Annexations. He did not seem to be concerned with Townships.

I also asked him about the logic behind no term limits for Local Government, he said he didn't know why local governments did not have term limits.

She had asked if workshop sessions agendas could be posted on the Website they all agreed it could and will start posting to the website. Audio sessions of the Regular Board meetings will be now posted but the workshop sessions will not.

She asked if the Ohio Checkbook could be updated more often. Discussion took place, It will stay the same.

Bowman construction brought in preliminary site plans. Reviewed the plan and talked about drainage. Also asked to revisit lot sizes with the zoning board. Process is for Trustees to pass a resolution that would instruct the zoning board to review.

I would like to make a motion to ask our zoning boards for updated recommendation to our zoning regulations specifically regarding minimum lot area, minimum lot width and frontage and any other conditions deemed appropriate related to lot size and width, Article 5, which is R1AAA,

residential Article 7 B2 which is office/residential district, and Article 8 which is neighborhood business district. With the condition that this would not take affect until after the joint meeting with the zoning commission and BZA.

Trustee Black asked for a second. Motion is dismissed because we don't have a second.

Trustee Black: Stated that he also went to the OTA conference, he attended the Ethics session and said the presenter was fantastic.

He learned in another session some different types of paving rejuvenation and maybe the Township could look into.

He received a complaint about the potholes on Singer Rd.

Administrator Ehrhart said the Road Crew were aware and would put cold patch down.

He attended a session on zoning that was terrible. Presenter was focused on suburban Development.

He also attended a session on 8 steps to prevent Annexation. What I came out of that session was we are doing what we can do. One of the other suggestions there were merging. And

Trustee Reese said maybe we should merge with New Carlisle. I don't think we are going to want to do that when we come in here this evening and we hear about annexation with New Carlisle.

PUBLIC COMMENTS FOR ITEMS ON THE AGNEDA

Donna Hughes asked the Trustees why they didn't second the motion.

Trustee vanHaaren replied that she did not want to direct the zoning boards to make recommendations for changes prior to their joint meeting. We have several new board members and would like to meet everyone and go over the roles and responsibilities of the Boards first.

Resident Donna Hughes stated that made sense and understood.
