

There are four Resolutions on the agenda this evening.

The first 3 are for new appointments to the Board of Zoning Appeals and Zoning Commission. Zach Staudter and Pete Mannheim have both expressed interest in the BZA and Ron Corbett has expressed interest in the Zoning Commission.

Lastly there is a Resolution to approve the Township's liability policy through OTAEMA. This year's premium was an increase of \$1,964 from \$20,097 in 2021 to \$22,061 in 2022

Resident Michelle Phrogner asked if she had missed the BZA meeting this past week. Zoning Administrator Mike Arnold said yes, that the meeting had been moved due to the OTA conference.

TRUSTEE DISCUSSION

Trustee Julie Reese reported that she talked to Randy Mott at Elizabeth Township about a Farmland Preservation Program. That maybe the Township could take a look at.

Trustee vanHaaren stated that the Trustees were aware of such program, but they have not done a program since 2015. The Ohio Department of Agriculture did not fund the program in 2021.

Trustee Don Black stated that Elizabeth Township received their money from the Berry Estate and they have a lot of money to fund programs like this.

Trustee Julie Reese stated she is working with Bethel Local Schools to set up a joint meeting.

Trustee Julie Reese reported that at the Huber Heights meeting there was no mention of Anneations. They did talk about revitalization. They discussed possible Commercial area, green space, Premier Medical Center and 55 and older apartments. They invited developers to come. Maybe we should do the same.

Trustee Reese stated she is looking forward to the upcoming OTA Conference.

Trustee Don Black reported on the Property on 5th Street and Walnut he continues to monitor the property. It has been labeled condemned by Miami County Health District.

Trustee Black wanted to thank the Road Department stating they do a great job taking care of the Roads.
