

RESOLUTION #22-06-048

A RESOLUTION DECLARING THE INTENTION TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION AND REQUESTING OF THE AUDITOR OF MIAMI COUNTY, OHIO, CERTIFICATIONS UNDER SECTION 5705.03 OF THE OHIO REVISED CODE

WHEREAS, it appears that the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of Bethel Township, Miami County, Ohio, and for the benefit of the incorporated and unincorporated areas of the same, and that it is necessary to levy a tax in excess of such limitation for the purpose of providing for the current expenses of Bethel Township, Miami County, Ohio, pursuant to Section 5705.19(A) of the Ohio Revised Code, and it is the intention of the Board of Trustees of said Township to levy a tax in excess of said limitation; and

BE IT RESOLVED, by the Board of Trustees of Bethel Township, Miami County, Ohio, no fewer than two-thirds (2/3) of all the members thereof concurring, that said levy will be for the purpose of funding and providing for:

THE CURRENT EXPENSES OF BETHEL TOWNSHIP, MIAMI COUNTY, OHIO,

as permitted by Section 5705.19(A) of the Ohio Revised Code, in a total rate and amount which shall not exceed three and eight-tenths (3.8) mills for each one dollar (\$1.00) of valuation which amounts to 38 cents (\$0.38) for each one hundred dollars (\$100.00) of valuation, to be levied for a period of five (5) years and to be placed upon the tax lists and duplicate beginning in the tax year 2023, as is permitted by Section 5705.191 of the Ohio Revised Code, and to remain on the tax lists and duplicate for the tax years 2024, 2025, 2026 and 2027, and to be first due and collected in the calendar year 2024 and to be further due and collected in the calendar years 2025, 2026, 2027 and 2028; which proposed levy shall be a **REPLACEMENT LEVY**, which shall replace an existing levy in the same amount and for the same purpose, and which will effect the imposition of taxation for said purpose; and be it further

RESOLVED, that the Board of the Trustees of Bethel Township, Miami County, Ohio, hereby requests that the Auditor of Miami County, Ohio, certify to said body the total current tax valuation of the property within the incorporated and unincorporated area of said Township, and the estimated dollar amount of revenue that would be generated upon said valuation by the millage as set forth hereinabove assuming the tax valuation of the property within the area remains constant throughout the life of the levy, as required by the terms and provisions of Section 5705.03(B) of the Ohio Revised Code; and be it further

RESOLVED, that the Fiscal Officer of Bethel Township, Miami County, Ohio, be, and said officer hereby is directed to certify a true and correct copy of this Resolution, and to forward the same to the Auditor of Miami County, Ohio; and, further, that said officer request of the Auditor that he cause the certifications alluded to hereinabove, as are required under Section 5705.03(B), to be provided to the Board of Trustees of Bethel Township, Miami County, Ohio, as soon as may be practicable hereafter.
